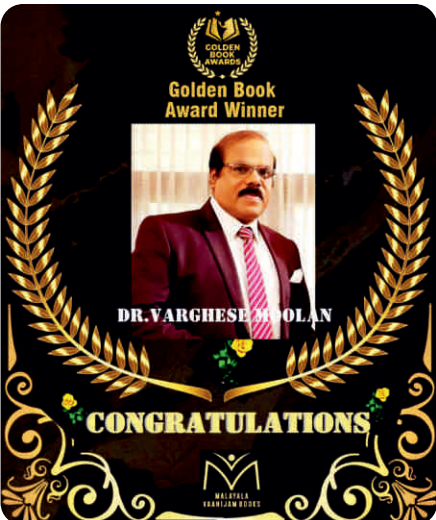

Born to Devassy and Alia at Moolans Tharavad, Angamaly, Varghese Sebastian, commonly known as Varghese Moolan had his Education at St. Joseph's High School, Angamaly; Pre Degree with Second Group, at Sacred Heart College, Thevara, Cochin; and graduated in Zoology, Botany and Chemistry from Sree Sankara College, at Kalady under Kerala University.

He was the college basket-ball captain of Sree Sankara College during the years 1976-77. He was the Ernakulam District Secretary of All India Catholic University Federation (AICUF) for two consecutive years during 1976 & 1977.

During the campus period, he wrote two novels: the first one "Thekku" (manual pumping of water) got the third place in the Mammen Mappila Award competition, and the second novel "Erimalayilorbhayaam" ('taking refuge in a burning volcano') got the fifth grade in the Kumkumam Award competition. He also used to write articles in various contemporary publications.

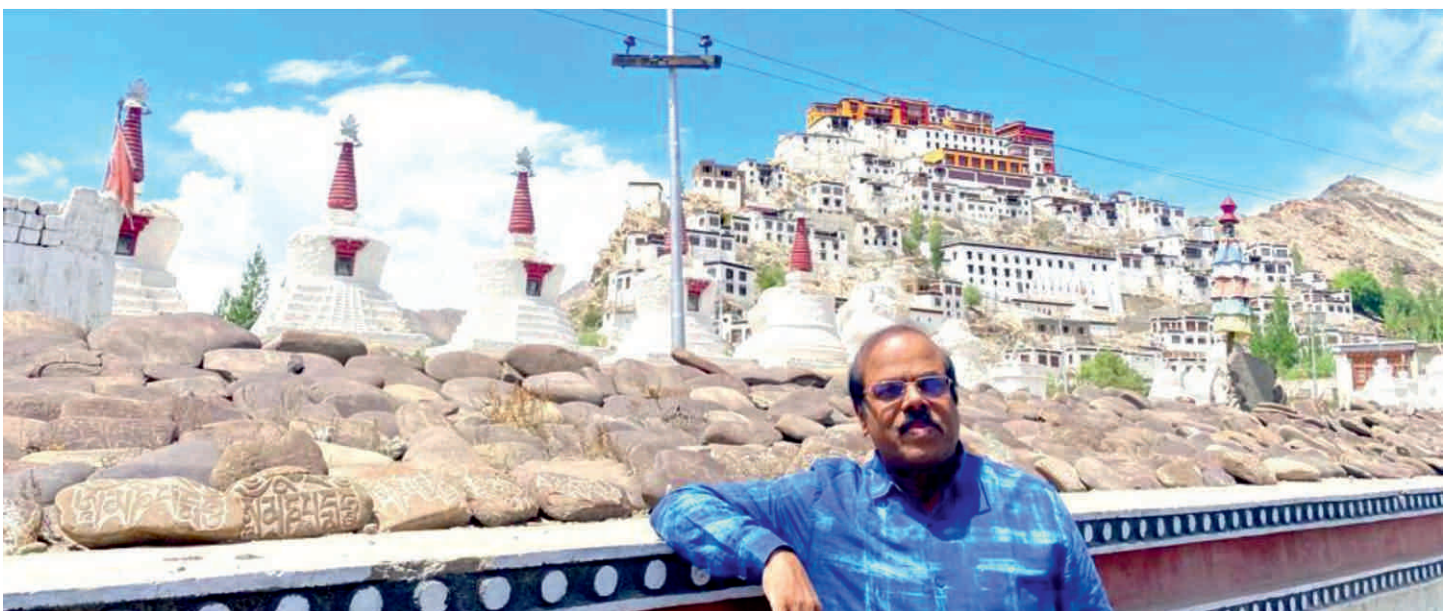
After Graduation, Varghese got employed in the leading News paper, Indian Express Group in Madras, Tamilnadu. Later he got employed as the Country Manager of Santul India Company, an original automobile spare parts manufacturing company, in New Delhi, with its factory at Aligarh, U.P.

He had to travel extensively across all states and main cities of India in connection with automobile parts marketing, which helped him a lot to realize the real status of Indian villages and could merge with the diverse Great Cultures and beliefs of the Great Indian subcontinent.

During his travels to Kashmir, Varghese used to visit the tomb at Rauza Bal, Khanyar, in Old Srinagar, where Jesus is believed to have been buried after a long normal life in Kashmir.

Varghese also lived a Buddhist monastic life for nearly 2 months in the “Hemis monastery” (Hemis Gompa) in Ladakh, where, as per ancient Buddhist records, Jesus Christ had lived a Monastic life, from his teen age of 13th (Buddhist Calendar year 555) till he was 24 years old, and Jesus is believed to have been later traveling in the ancient Buddhist and Vedic spiritual centers in all of North India radiating spiritual energy.

Varghese used to write articles in the leading publications like times of India, Indian Express and Manorama Sunday Supplements under the pen names of 'Anuranj' and 'Niranjker'. He was also an incessant student of the Vedic Literature and culture and the gradual evolution thru various laps of History.

During 1980 Varghese made an Anthropological exploration among “Savara” aboriginals in 'Gondwana' Sector, (situated on the joint borders of Bengal, Bihar and Orissa states) by staying among them for nearly 2 months. Thus he presented an anthropological thesis namely, “some of the fourth grade citizens of our nation.” which was published in Manorama News paper in 9 chapters.

During 1981 Varghese migrated to Saudi Arabia under employment, as the manager of Al-Saleh Group.

Later he started a supermarket in the name and style “VIJAY Supermarket” at Al-khobar, Saudi Arabia during 1985, named after his new born son Vijay.

Later he started a grocery packing unit and distribution network for spices, curry powders, groceries, Philippine and Thai foods in Saudi Arabia during 1986 in partnership with his sponsor Eng. Khalid Saud Al-Saleh, who was instrumental in establishing Varghese Moolans Group, with his financial support.

At that time, the quality and standard of Indian spices and food products available in the Middle East Markets were so sub-standard that even Indians preferred the products of other countries especially Pakistani products.

Consequently Varghese started a factory in India during 1987 and started manufacturing and exporting spices and groceries under the brand “VIJAY”, named after his son.

By the implementation of incessant and rigorous marketing strategies like persistence of quality, adoption of international standards in packing, and timely distribution of quality products, along with other measures, comprehensively opted by Varghese, reversed the International negative trend towards Indian Products.

And thus, during the middle of 1990s, the demand for Indian Products started to increase steadily. Thus Indians, Arabs and finally Pakistanis started consuming Indian Food Products. Alongside, Varghese also started Elite Super Market, Moolans Cold Storage and Nicee Studio and Colorlab in the Saudi Arabia.

Dr. Varghese Moolan is the first Indian to get the coveted “Saudi Investor license” (green card in Saudi Arabia) and the first Indian to become the member of the Saudi Chamber of Commerce during 2001.

Accordingly Varghese started the first 100% self-owned factory for manufacturing Spice products and Indian foods at Dammam, Saudi Arabia, under the name and style of “The House of Spices Factory Ltd,” at Dammam, Saudi Arabia.

Varghese is the first Indian to become the member of Saudi Arabian Chamber of Commerce.

During 1998, Varghese initiated the first of the Margin-free Super market chains in Kerala to regularize the rates of consumable items and to save the general public from exploitation.

Currently, there are one dozen retail and supermarket chains, under the names of Moolans Super Markets, Moolans Hyper Marts.etc, managed by him and 3 brothers.

During 2001 Varghese entered into the farming sector. He purchased dozens of acres of land in Palaghat district and started organic farming under the name and style of "Moolans Organic Gardens".



Thus many acres of Coconut trees, areca nut trees, gooseberry, Lemon plants, and other herbs are being grown. These products are used in manufacturing and exporting our food products.

Varghese has extensively travelled in the world, and visited more than 60 countries developing overseas markets of Vijay, Jay, Roma, Elite, Butterfly & other Moolans Group Products during the last 40 years, at the same time pursuing social encompassing among Indian Diaspora, under the umbrella of Global Malayalee Council.

All the biannual Global Meets in various countries were twined with these prospective, by including business meets, farmers' meets, exhibitions, cultural programs and charity projects.

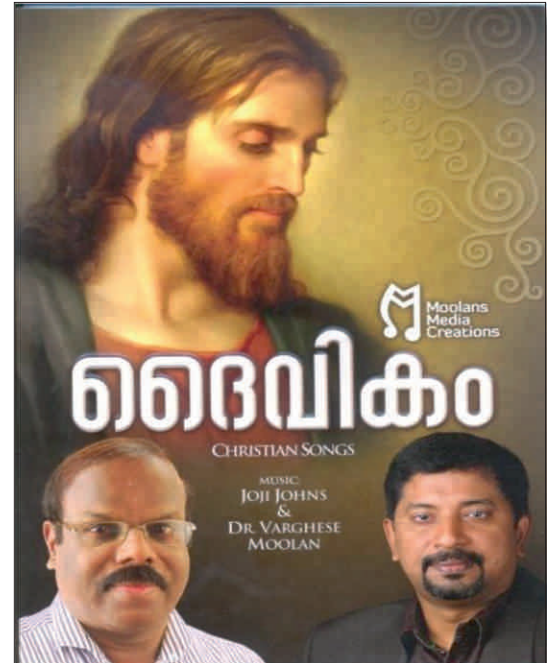

For diverting a part of the business profits and has taken up a lot of charitable projects.

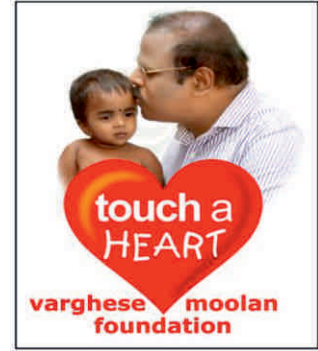

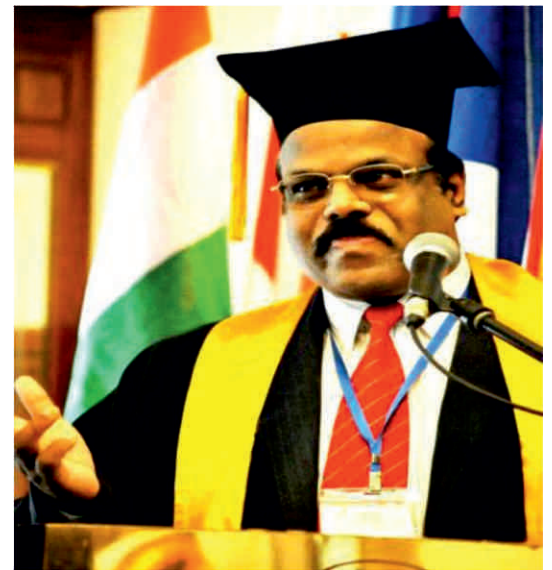
Some homes have been built who had land but no fund to build a house. Many houses which were attached by financial Institutions due to failure to pay the debts also were released under this project.

During the devastating floods that washed out Kerala during 2018, 4,500 kits (enough for 5 people for one week) were distributed among the most affected.

During the pandemic Kovid-19, during 2019-21 period, 20,000 food kits were distributed in every ward in the whole of Angamaly Constituency sufficient to feed nearly one lakh people for one week time.

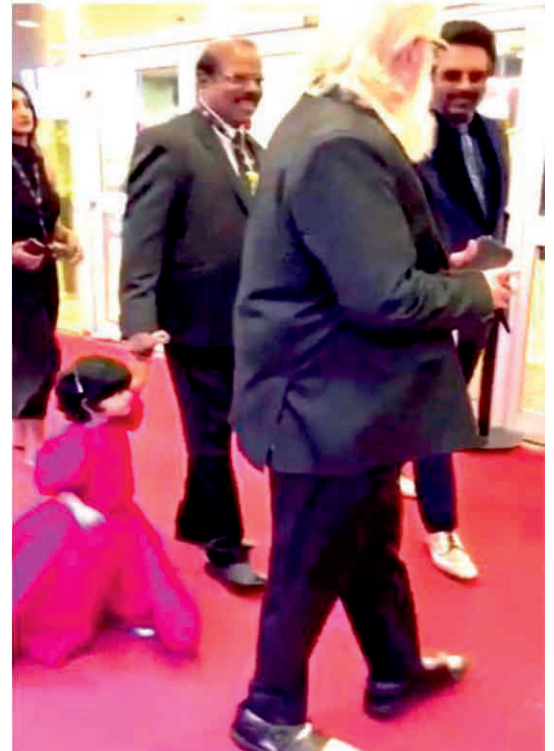

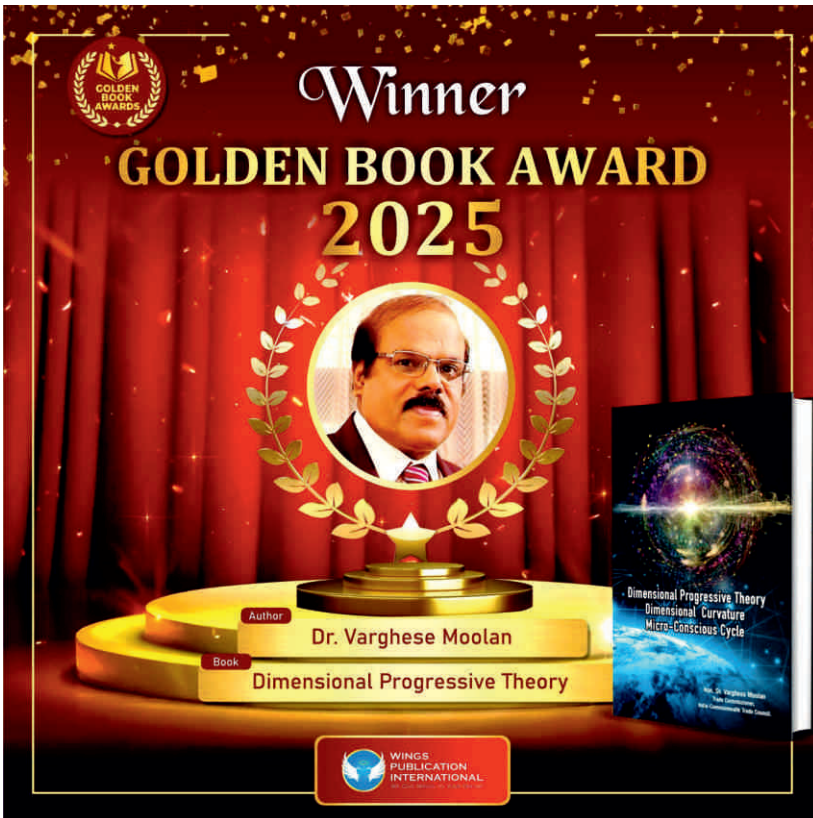
